This is for requesting a Custom Representation Agreement under section 7 for routine financial and legal affairs only. It is for different set-ups than the Basic RA7 F+L provided in the 'Plan for Financial & Legal' package.

This request is for **adults who are capable to understand** the nature and effect of making an Enduring Power of Attorney (EPA) and have determined that they want to use the RA7 F+L instead.
