New Residential Care Regulation

On October 1, 2009, a new Regulation came into effect for the *Community Care and Assisted Living Act*. The Residential Care Regulation replaces the old Adult Care Regulation and affects residential care services related to hospice/palliative care, long-term care, community living, acquired brain injury, mental health and substance abuse. consulted in the preparation of the new Regulation, issues we highlighted in other submissions were incorporated.

In a joint press release, the Ministry of Healthy Living and Sport and the Ministry of Health Services state that the primary focus of the new Residential Care Regulation is "protecting the health and safety of persons in care. New protection under the Regulation includes fall prevention measures, assessment for risk of wandering, banning of smoking by staff on the premises of care facilities, and strengthening health precautions on communicable disease."

In addition to these changes, the new Regulation spells out who must be listed as a contact person for the adult in care and clarifies their legal authority. As Nidus highlighted in Charting the Course Ahead, the old Regulation used eight different terms to refer to people involved in the life of an adult in care.

Nidus is pleased to see that our recommendations to clarify the terminology and include Representation Agreements were addressed. The new Regulation will ensure the legal authority of a representative is recognized, which will help protect the health, safety and wishes of an adult living in care and ensure the adult's voice is heard.
