## RA7F+L — routine financial and legal affairs only.

**NOTE:** Nidus recommends an RA7All instead of RA7F+L so that the Agreement also includes health and personal care matters. A person has more authority for health care as a rep. than as a spouse, parent or other next-of-kin. Only an RA covers personal care.
