Personal planning let's you authorize the people you trust to carry out your wishes when you need help.





We were very fortunate to meet with professionals who work in the health system and with physicians. Their ideas focused on ways to provide easier access for emergency personnel. Stay tuned for more news as we countdown to launch day.

Planning for the Future: Which documents cover financial and legal affairs?

There are two legal documents in British Columbia that can cover financial and legal affairs: 1) **Representation Agreement Section 7**; or 2) **Enduring Power of Attorney**. These documents are different in their capability requirements, areas of authority they can cover, and roles and duties of those appointed. Nidus has developed a fact sheet to explain the differences and similarities, and to answer 'frequently asked questions' about how these documents may apply in various situations. A Representation Agreement is part of establishing a safe, secure and self-determined future for 19 year olds with disabilities who may need the assistance of a representative now or in the future. Representation Agreements are also critical at the other end of the spectrum, as adults with disabilities age and may need advocacy support when they encounter the health system and residential care.
