Existing Registry Records will be Online Soon!

Existing records in the old Registry system are being transferred to the new system and will be available online soon!

It is very important to only have ONE Registry account. If you have an account in the old system, do NOT set up another one in the online system.

When the transfer is complete, notification will be sent to the email address on file with your existing account. Information will also be posted at www.nidus.ca/registry.

Once records are transferred to the online system, you will have the option to add to your account by registering more documents and filling in your Personal Information Record.

If there is no existing account, we will tell you how to create one in the new online system.

More Features and Benefits in the Online System!

NEW! Register a Personal Information Record!

The Personal Information Record (PIR) is the quickest and easiest registration to make—no need to complete a document first as required for other types of registrations. Simply select it under Registration Options, make payment, and you're ready to go!

You can type in contacts and keep an inventory of important details—past and present—about all life areas. It pulls together diverse information in one central place. It keeps things organized for you and for others who may need to know!


You can add, change and delete information in your PIR whenever you wish. You can also print a copy of a specific section or the whole record.

FOR EXISTING ACCOUNTS

Once existing accounts have been transferred to the new system, you will be able to register your Personal Information Record online. The fee is \$10.00 (to register an additional document on the account).


FOR FIRST-TIME ACCOUNTS (no existing account)

At the online Registry, click on *Create Your Account* and fill in the necessary fields then go to *My Account*. Select *Personal Information Record* from the list under *Registration Options*. The fee is \$25.00 to set up your account and register the first document. To create an account visit www.nidus.ca/registry

We have prepared a fact sheet to explain details of the Nidus Registry's security measures, which are informed by the expert advice of David Flaherty, privacy consultant, Gravit-e Technologies, the software development company, and members of the Law Society of BC who helped review and draft our policies.

Please familiarize yourself with the Nidus Registry policies outlining the rules around who can create an account, how to protect access to the account and what email address to use when setting up the account to ensure it stays secure. You are in control!

It is important that all Registry users—the public, lawyers and notaries, service providers (especially those in the community living sector) and government agencies—learn about their responsibilities in keeping information safe and secure.

Give access to others without compromising security! A new feature will be added to The Registry which will allow an Account Holder to share certain information and documents with others—for example: a representative or monitor, your financial advisor, your physician—while keeping your password private.
